- C** I would tell you, but I don't want to wear out the "0" key on my laptop.

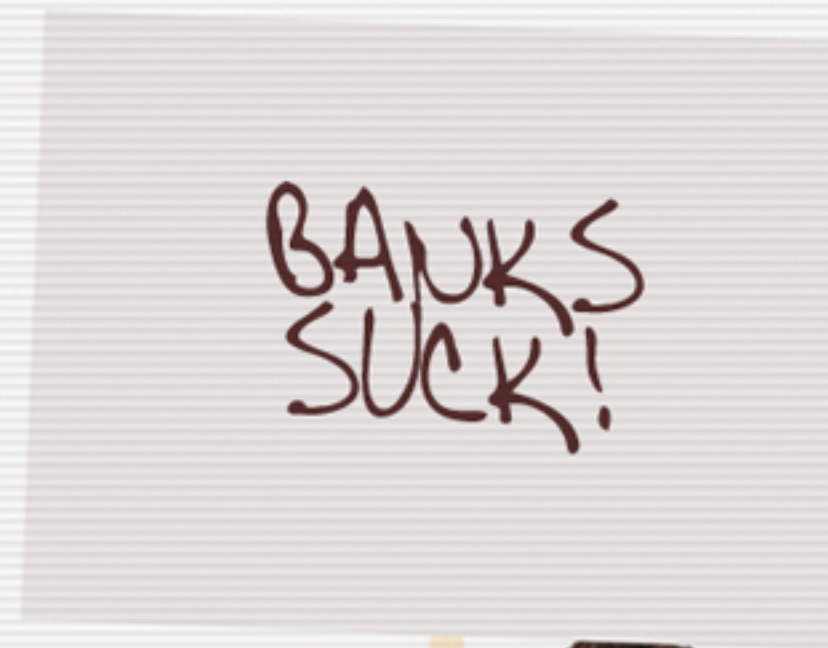
3. Do you think billionaire banking CEOs are...
